Getting SSDI and VA Disability Benefits at the Same Time

If you are a veteran with a service-related disability who is receiving Veterans Administration (VA) disability benefits, you may also be eligible to receive Social Security Disability Insurance (SSDI) offered through the Social Security Administration (SSA). Both disability programs are very different and have different requirements, but you can be eligible to receive monthly benefits from both.

If you are receiving VA disability benefits already, it may help speed up the processing of your SSDI claim. While the VA just requires that your disability is service related, SSDI requires that you have paid adequate taxes to the SSA and earned sufficient credits to receive benefits. This is usually the equivalent of five years of full-time work out of the last 10 years. However, that can be adjusted depending on the individual's age. If you have been approved for VA benefits, you should apply for SSDI right away before your <u>credits</u> expire. The Differences Between the Two Disability Programs

While VA disability is only awarded to veterans who suffered a disability related to their military service, SSDI is available to workers who have earned sufficient credits during the last few years. To get SSDI, you must be fully disabled, rather than being rated on a scale out of one hundred. VA benefits are only for disabilities that resulted from your military service while SSDI benefits are available for <u>any disability</u> you may experience regardless of whether it was service related.

While both the VA and SSA are government agencies, the application and approval processes are very different. The VA program looks at your file and decides the amount of your disability based on your military service. The SSDI claim looks at your entire file and gives more credit to your treating physician who knows more about your condition. All your medical problems are given consideration as the combination of multiple problems can lead to disability as well resulting in approval for SSDI benefits.

How Getting VA Benefits Can Improve Your Odds of SSDI Approval

If you have received a higher compensability rating from the VA, such as 70%, your odds of being approved for SSDI is much greater. When the SSA knows that another federal agency has already determined that you are unable to work or that you have a condition that makes maintaining full-time work difficult or impossible, your odds of being approved for benefits improve. If you have a service related disability with a compensability rating of 20%, but you also suffer from medical conditions such as diabetes and COPD, all those conditions are considered together and your odds of approval are also much greater.

Applying for Benefits

Many people have claims for VA disability and SSDI open at the same time. It is imperative to file your claim for SSDI benefits as quickly as possible so you don't lose your credits as well as your eligibility for those benefits. When you apply for benefits, you can use the assistance of an advocate or an attorney. To apply for SSDI benefits, visit www.ssa.gov or call 1-800-772-1213. You can also start your claims process in person at your local SSA office.
