Subscription Dues and Life Amnesty Membership Programs

Do you know how subscription dues work and the new/revised terminology? How it works. As an example, let's say a member's dues lapsed on the 31st of December and you collect and process his dues on the 1st of April. He is now paid through the 31st of March the following year – he gets 12 months of membership for his money. Now, let's say a member's dues lapse on 31 May and you collect and process his dues on the 15th of April – 45 days early. His dues will now expire on the 31st of May the following year. He still receives 12 months of membership for his money. Simple and fair – each subscription dues member receives 12 months of membership for his money!

How about the new/revised terminology? We still have expired and unpaid members. Expired – anyone whose dues have lapsed. We'll say his dues expired on the 31st of December. It is now the 1st of January. The member's dues have now expired. Unpaid – anyone who has not paid their current dues for the current membership year – IE their dues expire before the 30th of June. You receive no credit in Memstats for this member until he pays his dues. Continuous – a member who has paid his current membership year dues. And finally, the new term, Member in Good Standing. This is anyone who holds an unexpired membership card. The trick here is a Member in Good Standing can also be Continuous or Unpaid as well. If he has paid his current year's dues, he is a Continuous Member in Good Standing. If he has NOT paid his current year's dues and his membership has not yet lapsed, he is an Unpaid Member in Good Standing!

With the new subscription dues program comes a new problem. It used to be everyone's dues expired on the 31st of December. Everyone concentrated on membership starting in November (I hope) with phone calls to their annual members asking them to pay their dues. Then in January/February started conducting dues renewal drives — phone call Saturdays with runners to collect dues from members. Now, dues collection is a year round process. Our "annual" members have dues that expire every month of the year! You have to make phone calls and see members to get their dues every month.

So what can you (we) do to help ease the issue with pursing members each month to get their dues? Educate your (our) members. It does not matter when their membership card expires, their dues are due on the 1st of July. We cannot count them for membership until they pay their dues. No matter when they pay, they will receive 12 months of membership for their money!

Lastly, are you aware of how the National Life Amnesty program works and why National started it? National VFW has stated it was created to encourage new quartermasters who go through their membership roster and report deceased life members from previous year by not penalizing the post the for these deceased members in Memstats. (By the way – it is fraud to collect life membership dues for deceased members!) So, how does it work? A QM reports a deceased continuous or life member during the current membership year. Their membership counts in Memstats for the current year, but an additional member must be recruited to replace him in Memstats the following membership year. Now let's say you report a life member as deceased between the 1st of July and the 31st of August. Your Memstats required number is decreased by one – IE you don't have to recruit a new member to replace him in Memstats.
