



The 117th Annual National VFW Convention was held July 23rd thru the 27th. It was a time to vote on organizational by-laws, attend business sessions and workshops as well as network with other veterans. The mission of the Conference was to approve new national priorities to guide the VFW as it lobbies Congress on issues important to the nation's veterans, service members and their families. Awards were presented on Monday including the All-American Posts. Two Nebraska Posts achieved All-American status. VFW Post 5289 in Pawnee City and VFW Post 4755 in Seward. 

### J. Douglas Whitaker Department Commander

Dear Comrades,

I wish to begin by thanking all members of this great organization for bestowing your trust and confidence in me as your Department Commander for the year 2016-2017. From the beginning of my journey through the chairs, I have been honored by the support you have shown me. I have heard many previous Commanders comment about how fast the time flies and I echo their sentiments. It has been a superb journey and I look forward to the coming year as I and Auxiliary President Sue Moore represent the members of the VFW and its Auxiliary.

Looking forward, there are some objectives that I wish to accomplish this year. First, I want to continue to build upon our membership program. The key to the VFW's success in advocating for veterans is our membership strength. As the number of Americans who have served in the Armed Forces continues to decline per capita, it is more important than ever that we keep our membership numbers high so that our voices will be heard in the Unicameral and the U.S Congress. To that end, I was approached by our State Adjutant with the idea of having a full-time membership chairman who would be responsible for assisting Posts across the state in recruiting and retaining members. I completely concurred with the idea and have appointed Senior Vice Commander Larry Gerlt as Membership Chairman, Past Commander Jim Pierce as his deputy and Past Commander Bernie Brosnihan as Life Membership Chairman. All three bring valuable

experience to the membership program and I hope that you take advantage of the services they can provide.

Second, I want the VFW to be more visible at the Unicameral. Nebraska veterans have a true friend in the Governor who has committed to exempting military retirement from state income tax. He has shown great leadership in working with our elected officials in the U.S. Congress to secure the mission of Offutt Air Force base which has a \$1.3 billion economic impact upon the state economy. Where we have not been successful is the Unicameral where advancing simple legislation such as a sales tax exemption on our Post's food sales has proven difficult. To that end, I have appointed Jeff Baker to be State Legislative Chairman and have asked him to develop a course of action for communicating to you important matters occurring in the Unicameral and mobilizing you to contact your State Senators. As we move into the 2017 Legislative Session, be on the lookout for regular emails from Chairman Baker on how you can help the VFW advance veteran related bills in Lincoln.

Third, also related to the Unicameral, I believe there is a lack of coordination within the state between the various veterans groups and the business community when it comes to advocating for pro-veteran economic policies. As the Governor recognizes, Nebraska's economic growth depends highly upon an educated and skilled work force which veterans bring to a local community. In an effort to coordinate the advancement of such policies, I have asked various groups and individuals to submit op-ed articles over the next year. The views expressed in the articles will be those of the writer, not the VFW, but the information will serve as a conversation starter between our groups.


Finally, my last goal is to improve Post compliance with the National and State by-laws. Over the last five years, I have observed many Posts not complying with reporting requirements nor paying their delegate fees. Approximately one third of all Posts were ineligible to vote at this year's convention.

The fact is these requirements are not too burdensome or expensive. Therefore, I have asked each District Commander to keep me informed of Posts who are falling behind in their reporting requirements as the year progresses. It is my intent to contact each of these Posts in order to ascertain the reasons for their lack of progress. In addition, if your Post was not eligible to vote at this year's convention, it is my intent to contact the Commander and Quartermaster in an effort to prevent this from occurring again. As Commander, I do not want to make matters difficult but compliance with the by-laws is something I find important. More importantly, if a Post has a Canteen and it is not meeting the reporting requirements, I will discuss with the Post Commander and Quartermaster the risk of having the Post Charter suspended for failing to report. If a Canteen can pay the liquor distributor and file quarterly tax reports, the Post can file a trustee's report.

Thank you for all that you do to make the VFW the premier VSO in the state.

# WHY NEBRASKA IS MISSING THE BOAT WITH VETERANS.

Nebraska should make the effort to retain its military veterans.

Why should veterans seek more benefits from the State of Nebraska? The Nebraska Veterans Coalition has been working diligently to actively persuade Nebraska leadership to make more efforts to incentivize veterans to maintain their residency or emigrate to Nebraska. Without doubt, veterans in general are solid citizens and possess a considerable amount of leadership qualities training, self-discipline, technical skills, and experience in accepting levels of responsibility far above most non- veteran groups.

Nebraska currently has a .002% growth rate in its labor force. Nebraska has considerable challenges in providing a skilled workforce for businesses it has tried to attract into Nebraska. According to Adam Weinberg of the Nebraska Platte Institute, Nebraska Ranks Below National Average in Job and Population Growth. He states that from 2004-2014, Nebraska lagged behind the national average in employment growth., which measures the gross amount of new jobs created. Nebraska also lagged behind the national average in population growth. If that trend continues, Nebraskans will create less wealth and opportunity than their counterparts in in faster-growing states in the years ahead.

The Platte Institute has also opined that since 1992, out-migration of retirees has caused a "net

outflow of \$3 billion in annual adjusted gross income, and the people who created it, to leave Nebraska."

Why do retirees flee Nebraska? The main reason is taxation. Nebraska is one of only thirteen states who taxes social security and one of only five who tax social security and military retirement benefits. Why is this germane to the discussion? Because Nebraska needs people. A high-quality educated labor force, which in turn will create a wider base of tax revenue. Nebraska needs more businesses. Our military veterans provide a ready-made pool of well-trained, qualified and experienced leaders and workers in a wide variety of occupations. Nebraska has not made any substantial, concerted, or effective efforts during the past 40 or more years to retain veterans within the state. Many other states effectively recruit and retain veterans nationwide, and their efforts result in Nebraska being at the tail end of the pack in retention of veterans. There are many relatively simple efforts that Nebraska can undertake and should do to increase retention of veterans. Perhaps the two most effective avenues are to reduce taxation on military retirees benefits (as our border states already do) and make a concerted effort to attract and retain veterans to reside in Nebraska. Colorado exempts a large portion of military retired pay and increases that exemption at age 65; South Dakota and Wyoming have no state income tax; Iowa and Kansas fully exempt military retirement from state income tax,. Currently 17 states either have no state income tax or fully exempt military retirement income. Twenty-eight states exempt portions of military retirement pay at a set amount or base it on a formula.


# VFW'S VANDER CLUTE MEMORIAL RIDE RAISES OVER \$47,000




